- 046/16 Open Forum: There were no residents present.
- 047/16 The Minutes of the Amenities Committee Meeting held on Monday 3rd October 2016 were approved and signed by the Chair.
- 048/16 <u>Hall Maintenance:</u> Ongoing, the Chair is going to look at sourcing the extra lights for the ramp at the front entrance of the Village Hall. Flood lights are not suitable.
- 049/16 <u>Usage Reports:</u> The Village Hall usage was noted but there are no meaningful figures for the pavilion yet.
- 050/16 <u>Finance Reports:</u> The Village Hall figures were noted but there are no meaningful figures for the pavilion yet.
- 051/16 Park Inspection Reports: These have been received for October.
