22/7974 To consider S137grant applications from The Link Visiting Scheme, the Berkshire Multiple Sclerosis Centre, Home-Start Wokingham District and Berkshire Blind Society and grant applications for Twyford, Wargrave and District Volunteer Centre and 1st Charvil Scout group

It was resolved to grant £250 to The Link Visiting Scheme, £100 to The Berkshire Multiple Sclerosis Centre, £200 to Home-start Wokingham District, £200 to Berkshire Blind Society, £250 to Twyford, Wargrave and District Volunteer Centre and £595 to 1st Charvil Scout Group, which was passed unanimously.

22/7975 Planning, Environment and Highways Committee (PEH) – The Minutes of a Meeting on 29th November 2022 were noted.

To review the Queen's Green Canopy planting, and possible planting in future years

The project is now complete, although the Community Orchard continues for the next couple of years. It was decided that the Council would try to do some tree planting every National Tree Week, with Councillor Jones leading. The Council now has the advantage that it is working with the Borough Council, who are willing to support any planting the Council does. There has also been an offer from 1st Charvil Scouts to make bird boxes, which the Council would like to take up.

To consider a response to the Wokingham Draft Tree Strategy

The clerk was asked to respond to this, agreeing to all points apart from the length of time covered by the strategy, which should be longer in the opinion of the Council

To consider Planning Application 223465

Application for the proposed erection of single storey rear extension following demolition of existing conservatory at 23, Park View Drive South – no Parish Council comment

22/7976 Amenities Committee - The Minutes of a Meeting on 5th December were noted. To note the reports from the Fete Committee, and to consider whether to accept the requested date for the next year's event

The Fete Committee would like to hold the fete at the beginning of September, but this is not the preference for the Parish Council, as the football season will have already started, and would be happier if the fete returned to its historical time of June/July as this would allow for any ground damage to be repaired by the start of the football season.

Because it can take quite a lot of time to organise the fete, it was decided that it would be unfair to insist upon June or July for 2023, so that it can be held on 3rd September in 2023, with the Village Hall as a back-up, but from 2024 it will have to return to the June or July period.

To approve the recommended price increases

The price increases were unanimously approved, despite some reservations expressed by the clerk.

22/7980 To decide on a date and location for the first "Meet the Councillor" session It was agreed that this would take place in The Wee Waif on Thursday 12th January.
