# CHARVIL PARISH COUNCIL SAFEGUARDING POLICY

## Introduction

This policy defines how Charvil Parish Council operates the facilities available to hire under their management to safeguard children, young people and adults at risk of abuse or neglect.

The Charvil Parish Council has a duty of care and are committed to the protection and safety of everyone who enters the premises including children, young people and adults at risk involved as visitors and/or as participants in all activities and events. The Charvil Parish Council also has a duty to safeguard and support the Councillors, volunteers, and staff.

## 1. Definitions

**Children and young people** are defined as those persons aged under 18 years old. This policy will apply to all staff, contractors and volunteers and will be used to support their work.

Safeguarding and promoting the welfare of children is defined as:

- protecting children from maltreatment
- preventing impairment of children's health and development
- ensuring that children grow up in circumstances consistent with the provision of safe and effective care
- taking action to enable all children to have the best outcomes.

**Adult at risk of abuse or neglect** for the purposes of this policy, adult at risk refers to someone over 18 years old who, according to paragraph 14.2 of the Care Act 2015:

- has care and support needs
- is experiencing, or is at risk of, abuse or neglect
- as a result of their care and support needs is unable to protect himself or herself against the abuse or neglect or the risk of it.

If someone has care and support needs but is not currently receiving care or support from a health or care service, they may still be an adult at risk.

## 2. Persons affected

- All councillors, volunteers, and staff
- All those attending any activity or service that is being delivered from the facilities for hire under the management of the Charvil Parish Council
- All visitors and contractors

## 3. Policy principles

There can be no excuses for not taking all reasonable action to protect adults at risk of abuse, exploitation, radicalisation, and mistreatment. All citizens of the United Kingdom have their rights enshrined within the Human Rights Act 1998. People who are eligible to receive health and community care services may be additionally vulnerable to the violation of these rights by reason of disability, impairment, age, or illness.

Charvil Parish Council has a zero-tolerance approach to abuse.

Charvil Parish Council recognises that under the Care Act 2014, it has a duty for the care and protection of adults who are at risk of abuse. It also recognises its responsibilities for the safety and care of children under the Children Act 1989 and 2004.

Charvil Parish Council is committed to promoting wellbeing, harm prevention and to responding effectively if concerns are raised.

Charvil Parish Council is aware of the work of their local safeguarding Board/Partnership and other support organisations on the development and implementation of procedures for the protection of adults vulnerable from abuse. The policy is about stopping abuse where it is happening and preventing abuse where there is a risk that it may occur.

Charvil Parish Council is committed to the following principles:

- The welfare of the child, young person or adult at risk is paramount
- All children, young people and adults at risk have the right to protection from abuse
- Safeguarding is everyone's responsibility: for services to be effective each professional and organisation should play their full part; and
- All suspicions and allegations of abuse must be properly reported to the relevant internal and external authorities and dealt with swiftly and appropriately.

#### **4. Procedures**

- a. All members of the committee will familiarise themselves with safeguarding responsibilities and ensure that they understand the principles set out in this policy as detailed in point 3 above.
- b. All members of the Charvil Parish Council will work together to promote a culture that enables issues about safeguarding and promoting welfare to be addressed.
- c. No members or staff of Charvil Parish Council, helpers or other volunteers will have unsupervised access to children or adults at risk unless appropriately vetted.
- d. The Charvil Parish Council will follow safe recruitment practices.
- e. A member of the Charvil Parish Council will be appointed to be responsible for child and adult at risk safeguarding matters. This person will have responsibility for reporting concerns that arise, as a matter of urgency, to the relevant safeguarding agency.

- f. All suspicions or allegations of abuse against a child or adult at risk will be taken seriously and dealt with speedily and appropriately. The appointed person will know who to contact and where to go for support and advice in relation to an allegation a concern about the quality of care or practice or a complaint. An allegation may relate to a person who works with children or adult at risk who has:
- behaved in a way that has harmed a child or adult at risk or may have harmed a child or adult at risk.
  - possibly committed a criminal offence against or related to a child or adult at risk; or
  - behaved towards a child or children or adult at risk in a way that indicates they may pose a risk of harm to children.
- g. The Charvil Parish Council will ensure that all hirers using any of the facilities available for hire have signed or agreed their acceptance of the relevant Conditions of Hire. This will require all hirers who wish to use the hall for activities which include children and adults at risk, other than for hire for private parties arranged for invited friends and family, to produce a copy of their Safeguarding Policy and evidence that they have carried out relevant checks through the Disclosure and Barring Service (DBS). If the group does not have their own dedicated policy then they must agree to adopt the policy laid out by the Charvil Parish Council.
- h. All Hirers must accept that when using any the facilities under the management of the Charvil Parish Council, that it does not directly provide care or supervision services to children and adults with care and support needs, it expects all children and adults with care and support needs using its facilities to do so with the consent and the necessary supervision of a parent, carer or other responsible adult.
- i. The Charvil Parish Council will carry out an annual review of this policy.
